QUESTIONS

1. Question: The outside ledge of the canopy fascia, at the bottom; do you want that outside ledge protected? Also, the open/close lane signs (the birds can sit on them), and any other signs that are on that face, do you want them protected? The longer, rectangular signs that are down below, do you want them protected also?

Response: Please see the attached photo and sketch of these areas.

The outside ledge of the canopy fascia is not included.

The open/closed signs on the fascia are not included.

For the larger Daktronic Message signs which are attached to the bottom of the canopy, contractor shall enclose the uni-strut support framing with bird netting on all three sides. Keep the smaller control box outside of the netting or provide a zippered hatch in order to maintain access to that box.

2. **Question:** You're looking for the netting to be detachable so this way you can do work inside the netted area. How often do you have to go into that area other than the lights or the boxes which you have requested zippers?

Response: Other utilities inside the netting are electrical conduit, communications wiring, and a larger diameter pneumatic tubing system to each booth. These systems need periodic repairs on an ad-hoc basis, perhaps every 2 or 3 years.

3. **Question:** I went online to try to get the Prevailing Wage rates, and called the Department of Labor, they said I need a serial number to get the correct determination for the Prevailing Wage rates. Would you happen to know the serial number for this project?


